

REGISTRATION FEE \$25: Checks should be made out to the *Loudoun Preservation Society* and mailed to Al Van Huyck, P.O. Box 226, Round Hill, VA 20142.

INVITED GUESTS: Supervisors elect, Loudoun's state legislators, School Board members, and county officials. Also all members of the participating Coalition organizations and the general public.

LOCATION: REHAU, 1503 Edwards Ferry Road, Leesburg (just beyond COSTCO and TARGET stores, but on the opposite side of the road)
